ORDER

Administrative Approval is hereby accorded in favour of State Urban Development Agency (SUDA) for “Up-gradation/Establishment of Urban Health and Wellness Centre (U-HWCs) under XV FC Health Grants for FY 2021-22” at a total estimated cost of Rs. 14037736/- (Rupees one crore forty lakh thirty seven thousand seven hundred and thirty-six only), against unit cost of Rs. 3509434.00 per UHWC for a total of four (4) Urban Health and Wellness Centres.
