Order

An administrative approval and financial sanction is hereby accorded for a sum of **Rs. 9,50,14,964.00 (Rupees Nine crore Fifty lakh Fourteen thousand Nine hundred and Sixty Four)** only towards Performance Linked Incentive (PLI) to all eligible healthcare providers of 3937 operational Sub-centre Susasthya Kendras who have submitted report in SKMIS portal for the period **October, 2021 to December, 2021**.

2. District wise detail breakup of the released amount is attached at annexure 'A'.
3. Fund is hereby released considering 1 (One) CHO per Susasthya Kendra for the period October, 2021 to December, 2021. The entire fund to be sub-allotted to BH&FWSs based on the number of SC-SKs operational and eligible within the jurisdiction of the block.
4. BMOHs to release performance linked incentives to all the healthcare providers of SC-SKs on actual performance score and demand placed from the block as per memo no. **HFW/NHM-457/2017/35 dt. 06.01.2021**.
5. BH&FWS shall maintain pay slip against the performance linked incentive with a copy to be provided to the incumbent.
6. The charge (incentives for CHOs) is debitible to the **XV FC Health Grant fund from component head "Conversion of rural PHCs/SCs into HWCs"**
7. Sr. Accounts Officer, NHM will act as DDO for the said purpose.
8. This is issued with the approval of the Mission Director, NHM and Secretary, Health & Family Welfare Department.
