5. Efforts should be made to complete all activities under this component within April 2022.

6. District Magistrate/Executive officer Zilla Parishad shall be the nodal authority for this activity and select IA.

7. State Team may visit the sites to review the quality of works.

8. Still photograph of the activities under execution should to be kept in record at Engineering Cell of DPMU which would have to be submitted at SPMU, as and when required for future verification.
