ORDER

With the introduction of Revised Comprehensive Incentive Package vide GO No. HFW/NRHM/20/06/1104 dated June 13, 2011, ASHAs are entitled for receiving performance based incentive. It may be noted that regular activities of ASHAs, as mandated, will be hampered if they are called for training and she will not get incentive for those training days.


Hence, vide this order, it is approved that ASHAs will be eligible for a training allowance of

(1) Rs.75.00 (Rs. Seventy five only) per day for attending 3rd, 4th and 5th round of training.

(2) Rs.100.00 (Rs. One Hundred only) per day for attending 4 rounds of 6th and 7th module training.

(3) Rs.100.00 (Rs. One Hundred only) per day for any training they are being inducted into by any department/agency.

The budget for (1) & (2) is being approved under NRHM Additionalities. For any other training of ASHAs the concerned departments / agencies are hereby requested to allot necessary fund. This order will be effective from 1st November 2011.
