Only online application will be accepted. Application forms not properly filled in or incomplete Application forms are liable to be cancelled.
2. All the essential qualifications as mentioned in the above category must be completed on or before the first date of online application.
3. No Separate support towards conveyance shall be provided.
4. OPD Service for maximum 6(six) hours per day and for maximum 3(three) days per week .
5. Hard copy /print copy of the online registration form (printing within the last date of on-line application) should be retained by all applicants for document verification purpose. Without registration form, no candidates will be entertained for original testimonial verification by the authority. No need to send Hard copy/Print copy of the online registration form by post.
