- 5) If the incumbent proposes to cease his work without covering 1 month's notice period, his remuneration will be deducted accordingly.
- 6) The period of contract may be extended further on the basis of satisfactory performance.

- 8) The candidate should join **within 10 (Ten) days** from the date of issuance of the order. If 10<sup>th</sup> day is a Govt. holiday then the candidate may join on the next working day.
- 9) The candidate failing to report to their designated office within stipulated period may not be allowed to join later and his / her engagement is liable to be cancelled and the next candidate in the panel will be engaged accordingly.
