The candidates must bring undernoted **original documents**, along with one set of self attested photocopies of the same, for verification and submission:

3. The original photo identity proof (issued by any appropriate authority) of the candidate.
4. Proof of Address (Passport or Voter ID card or AADHAAR Card) etc.
5. Age Proof Certificate (Madhyamik or equivalent examination certificate).
6. All the mark sheets (**for all years / semesters**) and **course completion certificates** of all educational qualification from class 12 onwards.

All the post qualification experience certificates issued and stamped by the appropriate authority starting from oldest to latest.(Experience certificates must consist of Name of the post, Employer's Name, Employee's Name, Date of joining(DOJ) and Date of Leaving (DOL)/current date in case still continuing otherwise his/her experience will be treated as invalid.
