West Bengal State Health & Family Welfare Samiti will engage personnel purely on contractual basis for the position of **Consultant Epidemiologist** under **National Urban Health Mission**, Department of Health and Family Welfare, Government of West Bengal.

Eligible candidates should apply online in the prescribed format as given in Department's Website from 11 am of 24th July, 2018 to Midnight of 8th August, 2018 for the mentioned position.

Only online applications will be accepted, Application forms not properly filled in or incomplete Application forms are liable to be cancelled. Application fees of ₹100/ for General candidates and ₹50/ for Reserved category candidates (SC, ST, OBC-A, OBC-B and PWD) have to be deposited through on-line / off-line mode. The amount is non-refundable (Details of on-line/off-line mode, payment details and important dates are given in General Information point no. 7&8)

All the essential criteria must be completed on or before the first date of online application

- Name of the Position** : Consultant Epidemiologist
- Number of Vacancies** : 14 (SC-6, ST-2, OBC-A-3, OBC-B-1, PWD-1, and UR-1)
(The number of vacancies may vary according to need)
- Remuneration** : Rs. 37,000 per month.
- Place of Posting** : Anywhere in West Bengal (District/HD HQ or Municipality/ Municipal Corporation as the case may be.)
- Required Qualification** : M.Sc. in Life Science (Life Science includes Botany, Zoology, Human Physiology, Physiotherapy, Micro- Biology, Biochemistry, Bio-Technology and Bioinformatics)
OR
Degree in Dental (BDS)
OR
Post Graduate Degree in Hospital Administration /Hospital Management
And
Proficiency in MS office is required.
Weightage will be given to candidates having PhD.
- Age (as on 1.4.2018)** : 40 years

Note:

For the above mentioned position the applicants must be permanent resident of West Bengal.

Age relaxation will be given for the reserved candidates as per govt. norms.

Selection will be done on merit and computer examination as per above mentioned scale of scoring. Applications will be shortlisted on the basis of obtaining marks in the final examination (highest basic qualification). From the short list, candidates will be called in 1:10 ratio against the declared post.

In Computer examination, candidates for the above mentioned position, will have to obtain at least 50% marks to qualify for further process.

General Information for the Applicants/Candidates

1. Only online Applications will be accepted. **Application forms not properly filled in or incomplete Application forms are liable to be cancelled.** If the online application details submitted by the applicant differ with the original testimonials, that application shall be liable to be cancelled.
2. If proper signature and photograph are not uploaded at the time of online application that application shall also be liable to be cancelled.
3. The Essential Qualifications mentioned are the minimum and mere possession of the same does not entitle the candidate to claim selection. **All the essential qualification must be completed within the first date of online application.**
4. Hard copy/print copy of the online registration form (printed within the last date of on-line application), should be retained by all applicants for document verification purpose. Without registration form, no candidates will be entertained for original testimonials verification by the authority. No need to send Hard copy/print copy of the online registration form by post.
5. On-line registration No. should be retained by all applicants for future reference. Employer is not liable to give any information regarding the on-line registration no. in future.
6. No rounding off of marks will be granted. Proportionate marking upto 2 decimal points will be considered.
7. i) Last date of Registration : Midnight of 31st July, 2018
ii) Last date of Submission of application Fees : 3rd August, 2018 (upto banking hours for off-line payment mode)
iii) Last date of full Submission of form : Midnight of 8th August, 2018
8. The online deposition of application fees can be done through net banking or credit/debit card system through an online interface. If the payment is successful, the candidate will be immediately reverted back to the link for final submission of the application form by using the application id already received at the time of Registration.

If the candidate wants to submit the requisite fee through offline mode he/she can do so with system generated e-challan. The fee can be deposited in any branch of United Bank of India (UBI) with the print out of the system generated e-challan after duly filling up the three parts of the challan. Out of the three parts of the challan, bank will keep one part and hand over the other two parts to the candidate. Candidates must preserve both copies with him/her for future reference.


The candidates can complete the procedure of final submission of application form within 2 subsequent working days from the date of deposition of the offline fees by

using the application id already received at the time of Registration along with the transaction id obtained from the bank.

Please do not deposit fee in more than one mode or more than once in one mode.

9. Caste Certificate issued within the first date of online application, by the competent authorities of West Bengal only will be accepted. In case of OBC candidates, category 'A' or "B" must be mentioned specifically in the caste certificate, otherwise the caste certificate will not be accepted.
10. In case of PWD candidates, Disability Certificate issued within the first date of online application, by the competent authorities of West Bengal only, will be accepted.
11. **Registration Number of Dental Council (wherever applicable) must be issued within the first date of online application.**
12. The candidates, if found ineligible after verification process, will not be called for the subsequent stages of the selection process.
13. The decision of the competent authorities regarding the recruitment is final.
