

1. The Candidates is subject to the final outcome of the petition filed WPA(P) 335 of 2022 Pijus Patra Vs. The State of West Bengal.
2. The engagement is made purely on contractual basis till 2025-26 i.e. will be co-terminus with the tenure of XV- Finance Commission Health Grant.

11. The order of engagement will stand cancelled if the candidate fails to join within 15(fifteen) days from the date of issuance of this order.


