ORDER

Md. Ruhul Amin, C/o Md. Osman Ghoni residing at Vill+PO-Kasbagola, P.S-Egra, Dist-Purba Medinipur, Pin-721447 is hereby engaged as "District Microbiologist" under IDSP on contract basis on a consolidated monthly remuneration of ₹ 35,000/- (Rupees Thirty five thousand) only, and posted in the Krishnagar District Hospital (DPHC) of Nadia District.

The order of engagement will take effect from the date he joins the position. The period of contract will automatically be terminated after expiry of 31-03-2018. The contract may be renewed on the basis of satisfactory performance. The service may also be terminated by one month's notice from either side. If the incumbent proposes to cease his work without covering 1 (one) month's notice period, his remuneration will be deducted accordingly.


