The candidate must bring undernoted original documents, along with one set of **self attested photocopies** of the same, for verification:


1. The original photo proof identity card of the candidate i.e. Passport, Pan Card, Voter-ID Card, AADHAAR Card (any one of this).

4. All the marksheets (for all years / semesters) and course completion certificates of educational qualification and professional qualification in original.
5. All the post qualification experience certificates issued and stamped by the appropriate authority starting from oldest to latest.
6. Experience certificates must consist of Name of the post, Employer's Name, Employee's Name, Date of joining(DOJ) and Date of Leaving (DOL)/current date in case still continuing otherwise his/her experience will be treated as invalid.
