- 6) The period of contract may be extended further on the basis of satisfactory performance.
- 7) The candidate are directed to report for joining the post at the office of **the secretary, DH & FW Samity and Chief Medical Officer of Health, Malda**, as mentioned against their names with downloaded engagement order, photo identity proof, address proof and caste certificate (if any) issued by appropriate authority and Medical fitness certificate (enclosed herewith) issued by the registered M.B.B.S. practitioners.
- 8) The candidate should join **within 10 (Ten) days** from the date of issuance of the order. If 10th day is a Govt. holiday then the candidate may join on the next working day.
