## ORDER

He will get a **consolidated monthly remuneration** which will be calculated as last pay minus pension as per State Govt. rules and posted at **State Programme Management Unit (SPMU), National Health Mission (NHM)**.

The order of engagement will take effect from the date he joins the position. The period of contract will automatically be terminated at the end of the current financial year. Thereafter, it will be for one year, unless renewed further. The engagement in the said position is for SPMU under NHM and shall be coterminous with NHM.
