ORDER

In reference to the recruitment notice no. SHFWS/2019/175, dated: 18/01/2019, **Sri Amal Chandra Barman**, residing at Kushiari Bari, Ghoksadanga, Dist-Cooch Behar, West Bengal, Pin-735211 is hereby engaged on contract for the position of **Data Manager** under **National Urban Health Mission (NUHM)**. He will get a consolidated monthly remuneration of ₹ **23,270/-** (twenty three thousand two hundred and seventy only) and posted at **North 24 Parganas** district.

The order of engagement will take effect from the date he joins the position. The period of contract will automatically be terminated at the end of the current financial year.
