ORDER

The following 22 (Twenty two) Auxillary Nursing Midwifery (Revised) qualified candidates are hereby appointed temporarily as Health Assistant (Female) under revised Cadre constituted under notification No.- Health/GA(N)/220/1N-52/86 dated 13.11.1987 read with the revision of pay rules as per WBS (ROPA) Rules, 2009 in the Pay Band scale of Rs.5,400- 25,200/-,PB-2 with Grade Pay Rs. 2600/- per month with other allowances as admissible under existing rules of Government of West Bengal and are hereby placed under Chief Medical officer of Health of the districts mentioned in column No.4 for posting in the existing vacancies or the vacancies of the sanctioned sub centres in the districts permitted to be opened as per G.O. No. H/HW/42/35-31/2002 dt. 12.02.2004.

One Health Assistant (Female) is to be posted in one vacant sub centre under the B.P.H.C./Rural Hospital. No Health Assistant (Female) should be posted at any place other than Sub-Centre in the district. Salary Head can not be shown for the H.A.(F) other than sub centre head of Accounts as per G.O. No. H/FW/SFWB/HNG/12C-7-96/PtIII/405 dt. 20.3.2002.

The salary of newly recruited employee under this order will be drawn from the head of Account "2211-00-001-SP-004-V".

This order is being issued with the concurrence of the Finance Department vide their U/O No. Group 'O' No. 252 Dated 12.02.2004"

They are liable to be transferred to any sub centre in the West Bengal in exigency of Public Service. Medical Examination of the candidates must be completed prior to their joining and they would be allowed to join if found fit.

Police Verification is to be done for all candidates and their services are liable to be terminated at any time without notice in case of any adverse Police Report against them or if they are considered unsuitable in anyway.


Three months notice will be necessary in case of resignation in absence of which one month salary will be forfeited. In case of discharge, one month's notice or one month's salary will be given.

Their date of joining as Health Assistant (Female) will take effect from the date of their reporting to the concerned C.M.O.H. in the district.

No T.A. is admissible.

This order will take effect immediately.




