ORDER

The undersigned is directed by the order of the Governor to say that **Administrative Approval & Financial Sanction** is hereby accorded towards the WBMSCL for the work "Civil work for Renovation of 7th floor of Academic Building for the purpose of initiation of Postgraduate courses at College of Medicine & Sagore Dutta Hospital" of Project cost of Rs. 3, 30, 955/- (Rupees Three lakhs thirty thousand nine hundred fifty five only) (including 4% WBMSCL charges and GST).

The fund will be released in due course, on specific demand, to the West Bengal Medical Services Corporation in deposit account in terms of FD Memo no. 3626- F (Y) dated. 10/07/2014, 1033- F (Y) dt. 20/02/2018 read with FD Memo No. 1466 F (Y) dt. 09/03/2018; to meet up the project cost. The Assistant Secretary, Health & Family Welfare Department will act as DDO in this regard. The fund will be disbursed subject to (i) strict observance of all relevant Financial Rules & Regulations including e-tender norms of the Govt., (ii) timely completion of the work to avoid escalation of cost, (iii) non-deviation of the allotted fund from approved scheme, (iv) there will be no deviations- technical or otherwise from the approved norms and (v) submission of utilization certificate of the fund allotted.
