**MEMORANDUM**

The undersigned is directed by the order of the Governor to say that the Governor has been pleased to permit **06 (Six) officers** of the West Bengal Health Services, as shown in the following table, to undertake **Post-Graduate Degree/ Diploma courses** at the places mentioned in column [G], for the session 2020 and for that purpose the Governor has been pleased to place them on the **Trainee Reserve for the period of three years in case of Degree courses and two years in case of Diploma courses** with effect from the date(s) of their release from present place(s) of posting or till the completion of the University examination of the course(s) for the first time whichever is earlier.

2. They shall be released under local arrangement from their present places of posting by the concerned controlling authority in order to enable them join their course, after handing over their official charges.
3. Meanwhile, if on scrutiny and vigilance verification, any candidate(s) is/are found to have been suppressing facts or furnishing false information, or in case of any adverse report,

his/her candidature will liable to be cancelled and appropriate administrative action will be initiated against.

4. During the period of their placement on Trainee Reserve, the Officer will draw Pay & Allowances as admissible to them under the West Bengal Health Services (Cadre, Pay & Allowances) Rules and in terms of the existing Rules of this State Government.
5. The Medical Officers, as placed on Trainee Reserve, are subject to the condition that they shall, prior to their drawing Pay as Medical Officer on Trainee Reserve, execute **bond in triplicate** in the prescribed form undertaking to serve the State Government for a period of at least **three years (in case of two years course) or five years (in case of three years course)** after completion of the course. The duly filled up bond should be submitted to the MERT Branch of Swasthya Bhawan for acceptance.
6. The Assistant Director of Health Services (Accounts) will act as the DDO in this regard while the Deputy Director of Health Services (Administration) shall act as Controlling Officer in respect of such officers.
7. The Pay & Accounts Officer-III, Kolkata, Pay & Accounts Office-III, Accountant General, West Bengal and other concerned are being informed.
8. They shall obtain release order from the concerned Institution immediately after completion of the course and report to the Director of Health Services, West Bengal for duties.
