The appointment of the candidate has been made on the recommendation of West Bengal Health Recruitment Board, Kolkata vide letter No. 1089/WBHRB/1R-13/2020 dated 31.12.2020 and will continue provisionally for 6 (six) months or until further orders with effect from her respective date of joining. If any declaration given or information furnished by the candidate is proved to be false subsequently, or in case of any adverse observation during verification of her antecedents or she is found to have willfully suppressed any material information, she will be liable to remove from service without assigning any reason and/or any such further action as the Government may deem necessary under provision of law.

3. The pay of the Nursing Faculty upon appointment as Senior Lecturer shall be fixed in the revised pay structures (Rs. 56,100/- - Rs.1,44,300/-) in Level- 16 of WBS(ROPA) Rules, 2019, vide Notification No. 5562-F dated 25.09.2019 of Finance Department (Audit Branch), Govt. of West Bengal.

4. The appointee is required to contribute compulsorily towards Group Insurance Scheme and General Provident Fund at such minimum rates as may be provided by the Government accordingly to rules.
5. The appointee shall be governed by the terms and conditions of the State Government Service and all rules and orders of the State Government as are applicable to the State Government Employees of similar category, shall also apply mutatis and mutandis in respect of the candidates. The appointment carries with it the liability of service in any part of West Bengal or outside. The appointee is required to perform all such duties as may be assigned to her time to time besides the duties of the post in which she is or may be appointed. All subsequent orders issued by the State Government apropos service terms, conditions and pay etc, shall also apply towards her.
6. The appointee is hereby directed to report herself for duty to the Head of the Institution concerned immediately and in any case not later than 4 (four) weeks from the date of issue of this order, failing which the offer of appointment to the West Bengal General Services (Nursing) Cadre shall stand automatically cancelled without further reference to her and vacancy will be filled up empanelled candidates as recommended by West Bengal Health Recruitment Board, Kolkata.

This appointment has been made as per the recommendations of the West Bengal Health Recruitment Board, Kolkata by the way of Lateral Recruitment in accordance with the exemption permitted in terms of G.O. No. 4969-F(P), dated 20.06.2013 and in terms of the Recruitment Rules notified under G.O. No. HF/O/MERT/1561/GA(Ng)/1M-76/2012 dated 20.12.2013.
