Reference above, it may be noted that out of 117 functioning FPMS, 89 have already been issued approval for renewal by the department along with draft agreement.

Now as per records there are 12 FPMS where renewal to be due within December 2019, for which proper recommendation with duly filled in each list as per Annexure 'I' needs to be send in advance. Delay in recommendation causes operational problems, as without proper renewal agreement Drug License may not be renewed by Directorate of Drug Control. Also there are issues of pending electricity bills, rent etc, etc. In some cases if the partners do not want to continue services, the Hospital authorities have to recommend future action and existing partner's needs to clear all dues before such recommendations well in advance.
