
Sir,

Reference above several letter were issued along with guidelines to hospital with approved check list, for sending recommendations for renewal of FPDC (CT, DR, MRI, PET Scan, Audio vestibular Clinic, Laboratories) and dialysis services in PPP mode, at least 6 months in advance to ensure early processing and approval. Till date 40 units have been provided approval for renewal, and another 18 units granted extension till 30th September 2019.

However it has been observed that there are several units from where delayed recommendations are received causing problem in processing and approval. In some places the recommendation received has been not complete and thereby request for re-submission issued. There are units where, Hospital has proposed termination or non extension of renewal but the proposal has not been send in proper format with reasoned order clearly stating their reasons for not being satisfied by the response of the private partners and quoting the exact violations done of the agreement's condition. The relevant clause of the agreement or the relevant order may also be put up. Also further plan of action may be recommended. (Circular issued vide Memo No HF/PPP/17/2016/940 dated 26.06.2018.)

You are hereby instructed to look into the matter urgently, especially for units where recommendation is delayed or there is any other issue for which action is suggested. The cause for such delay may also be communicated. Also for units pending renewal by Dec 19, please process for early recommendation. List attached in Annexure-A


Please send your communication (Either Recommendation for Renewal with duly filled check list) or proposal for non renewal/termination whatever decided at hospital level with complete documentation within 7 days to spsrc.ppp@gmail.com and pppdialysis@gmail.com .


