In order to cater the increasing load of patient in the Primary and Block Primary Health Centres of the State, the Department of Health & Family Welfare have decided to engage **Qualified Private Medical Practitioner** possessing **Basic Medical Qualification** as recognized by **Medical Council of India**, on the basis of **hourly fixed remuneration** for OUT-PATIENT DEPARTMENT service only.

The Department have also decided to **decentralize** the system of these engagements for prompt disposal of application.

A 3(three) member committee will be constituted **at the District level** under the **Chief Medical Officer of Health**. The other two members will be nominated by the CMOH. The Committee will scrutinize the applications and after exercising due diligence, including verification of documents, the **CMOH of the district will issue order of engagement according to the vacancy declared for this purpose.**

The detailed advertisement, inviting **on-line applications** from willing Private Medical Practitioners will be published in the Departmental Website. In this connection, the following protocol is to be followed:

1. Advertisement is to be made through Newspaper and other media.
2. Online System of Application, giving details of vacancies.
3. Intending Candidates will be allowed to choose 3 Health Facilities in priority.
4. Health facility to be allotted on first cum first serve basis.
