Subject: Renewal of IT personnel engaged through No-192-IT/6/2020 /P&AR-e-Gov dated 16.10.2020

In accordance with the observation of the Finance Department, it has now been decided that the IT personnel brought under the purview of Notification No-192-IT/6/2020 /P&AR-e-Gov dated 16.10.2020 issued by this Deptt. are required to be renewed annually as usual till their attaining the age of 60 yrs unless their services are terminated prior to that age limit due to the reasons as stated therein.

Provisions of Memo. No-1168-F(P1) dt. 23.03.2021 will not affect the entitlement of usual annual enhancement or remuneration of the IT personnel initially engaged in terms of No-5859-F(Y) dt. 22.07.2013 and subsequently brought under the purview of No-192-IT dt. 16.10.2020 till their remuneration structure is revised.


