**Order for release of in-service examinee batch of post graduate medical students by the medical teaching institutions in West Bengal after completion of their trainee reserve period**

The examinee batch of post graduate medical students was instructed to continue their service in their respective departments with immediate effect so that they may be utilized for COVID duty till further orders vide memo no M/862 dated 29.04.2021 in view of the postponement of the broad speciality exams by WBUHS vide memo no COE/UHS/788/2021 dated 29.04.2021 and advisory issued by the National Medical Commission to all medical colleges vide memo no NMC/Secy/2021/25 dated 27.04.2021.

Among the examinee batch of post graduate medical students there are in-service candidates whose trainee reserve (TR) period is going to lapse in June or July 2021. Such candidates shall be released by the teaching institutes on completion of TR period. Such candidates on release have to join as Medical Officer on Supy duty at Swasthya Bhavan and thereafter they shall be posted to their training institutes or other hospitals in districts as per need till the completion of university exam.

After completion of university examination their posting may be reconsidered by the Swasthya Bhavan depending on COVID 19 situation. E-joining after completion of TR period in colleges situated in any area other than Kolkata shall be allowed for in-service candidates considering the restrictions in movement.
