ORDER

The Health & Family Welfare Department is providing the most prime essential services to combat the recent surge of COVID-19 infections.


Order No. 21-CS/2020 dated 23.03.2020 of the then Chief Secretary, Government of West Bengal states that “ However, various Departments and Officers have to play essential role for providing support services to essential service – rendering offices and all such offices shall remain open in public interest”.

Further, Order No. 1587-F (H) dated 16.04.2020 of the then Chief Secretary, Govt. of West Bengal states that “ Those establishments which are providing essential services and had been excluded from the restrictions imposed under Order No.21-S/2020 dated 23.3.2020, will continue to function as usual until further orders.”


