The undersigned is directed by order of the Governor to say that the Governor has been pleased to allow contractual engagement of 01(One) Librarian each to all the Hospitals as mentioned below for a period of one year or till regular recruitment is made (with effect from date of joining), whichever is earlier from Retired Librarians below the age of 64 years at a monthly consolidated remuneration of Rs. 15000/- or on re-employment pay whichever is less in the following 8(eight) Hospitals:-
