**ORDER**

Delegation of power up to Rs. 25.00 Lakh to the (1) Principals of Medical College & Hospitals and (2) the District Magistrates of the concerned district for execution of COVID related works of the COVID Hospitals was accorded vide this Department's Memo No.109-HS(MS)/386691/HFW-43011(11)/85/2021 dated 30.04.2021 with concurrence of Finance Department vide their U. O. No. Group T/2021-2022/0060 dated 30.04.2021.

However, there are demands that this limit of Rs.25.00 Lakh is not sufficient to deal with the COVID related Schemes specially in the face of rising COVID positive cases across the State.

After careful consideration of the matter and in continuance of the aforesaid order, it is reiterated that the **limit of Rs. 25.00 Lakh is hereby increased to Rs 50.00 Lakh** for smooth and speedy execution of COVID related schemes across the State.

All the concerned authorities are requested to adhere strictly to the norms in consonance with the guidelines that have been laid down in the aforesaid order in terms of sanction and execution of all the COVID related schemes.

This order is not an authority to incur expenditure and all funds so provided shall have to be utilised upon strict observance of all financial norms and extant rules and regulations being enforce for the time being.
