The undersigned is directed to say that the payment of subsistence allowance i.r.o. Dr.Kamalesh Bhattacharya who was attached as M.O. to Balarambati Primary Health Centre, Singur, Hooghly may be re-started immediately which was stopped since July, 2019.

Dr. Bhattacharya has been kept under suspension from 20/06/1995 vide Memo No:- HF/O/GA(Vig)/342/9A-105/94 dt 20/06/1995. He was paid subsistence allowance upto June, 2019 which was stopped from July, 2019 till date on account of an objection raised by Treasury Officer, Chandernagore Treasury in his Pay Bill vide Token No:-2571 dt 26/07/2019.

Now, It is further directed to say that the objection raised by T.O. ,Chandernagore Treasury is to be met by the D.D.O. of the incumbent and to re-start payment of subsistence allowance as early as possible.
