**ORDER**

In continuation of this Department's Memo No. I/29509/2018 dated 11/10/2018 read with No. HF/O/TDE/1309/3C-04/2010 dated 27/09/2018, the undersigned has been directed to authorize all Hospitals and District Reserve Stores under the administrative control of the Government of West Bengal to procure drugs, medicines, implants and essential consumables like Reagents, Chemicals, Laboratory and Diagnostic Kits etc. from the Fair Price Medicine Shops (FPMS) mentioned in the Annexure to this Order, in addition to the 05 (five) FPMS already notified, as they have subsequently agreed to supply CAT items at the CMS approved rates, in case of urgent necessities, in the interest of patient services, as and when necessary, subject to the following terms and conditions:

- (A) All such procurement shall be made through the Store Management Information System (SMIS) application currently being used for inventory management in respect of drugs, medicines, implants and consumables etc. in the Health & Family Welfare Department.
- (B) Procurement from FPMS in respect of any CAT item shall have to be at rates not exceeding the current Central Medical Stores (CMS) approved rate for the item and procurement from FPMS shall be resorted to only in the event of failure of the CMS enlisted vendor to fulfill the Purchase Order within the timeline fixed (including grace period) as per the Tender.
- (C) Life-saving drugs and other important drugs, medicines, implants or consumables considered essential for treatment of patients but not listed as CAT item or listed as CAT item but blocked in SMIS may also be purchased from the FPMS at the CMS approved rates. If no CMS approved rate is available for any particular item, the rate fixed by the National Pharmaceutical Pricing Authority (NPPA) should be followed and no item should be purchased at rates above such CMS / NPPA approved rates.
- (D) If no CMS approved rate is available for any particular item or the rate fixed by the National Pharmaceutical Pricing Authority (NPPA) is also not available, local purchase may be followed observing financial norms for life savings Drugs, Medicines, Implants and essential Consumables only, as per extant orders.
- (E) Procurement of items from the FPMS should however be limited to 20% of the total fund placed to the particular Hospital/ DRS for procurement of Drugs, Medicines, Implants and essential Consumables etc.
