## ORDER

Administrative Approval is hereby accorded for the scheme 'Construction of 13(thirteen) nos. of Non-GP Head Quarter Sub Centre at Paschim Medinipur District' at an estimated cost of Rs.1,66,49,100/- (Rupees One crore sixty six lakh forty nine thousand & one hundred only).

2. Each Sub Centre will have to be built at the sites as communicated to this Department at an unit cost not exceeding Rs.12,80,700.00 (Rupees Twelve lakh eighty thousand & seven hundred only) as per model plan & revised estimate with revised PWD SoR and introduction of GST from 1<sup>st</sup> July, 2017.
