Subject: Granting of CAS benefit after completion of 8 (eight) years of continuous and satisfactory service in respect of Smt. Sova Gunri, District Public Health Nursing Officer (D.P.H.N.O.), CMOH Office Birbhum, Dist.- Birbhum.

MEMORANDUM

Smt. Sova Gunri, attached to CMOH Office Birbhum, Dist.- Birbhum was appointed to the post of District Public Health Nursing Officer (D.P.H.N.O.) under West Bengal General Service (Nursing) vide Notification No. HF/O/GA(Ng)/110/1N-45/96/Pt.I dated 24.07.2012 along with the recommendation of PSC, WB vide No. 110-PSC(IVA) dated 18/03/2011 and joined the said post w.e.f. 01.08.2012 in the Pay Scale of Pay Band 4A (Rs. 15,600-42,000/-) with Grade Pay Rs. 5,400/- under WBS (ROPA) Rules, 2009 corresponding to Level-16 (Rs. 56,100-1,44,300/-) under WBS (ROPA) Rules, 2019.

2. The benefit under CA Schemes has been due to her since 01.08.2020 for completion of continuous and satisfactory service of 08 (eight) years in the same post without any promotion on 31.07.2020. Smt. Sova Gunri, is, therefore, eligible for Career Advancement in the next higher scale of Pay to the Level-17 (Rs. 67,300 – 1,73,200/-) of Pay Matrix under WBS (ROPA) Rules, 2019 w.e.f. 01.08.2020.


3. In the circumstances stated above, the Governor has been pleased to allow 08 (eight) years' Career Advancement benefit to Smt. Sova Gunri, DPHNO, attached to CMOH Office Birbhum, Dist.- Birbhum w.e.f. 01.08.2020 in terms of F.D. Memo No. 3015-F dated 13.03.2001 read with Finance Department's Memo No. 961-F(P) dated 07.02.2011 and 6042-F(P2) dated 07.11.2019 in the following manner.

a). She is entitled to draw her pay in the Pay level-17 (Rs. 67,300- 1,73,200/-) of the Pay Matrix under WBS (ROPA) Rules, 2019 w.e.f. 01.08.2020.

4. Her new enhanced pay will be fixed as per the option exercised by her.

5. The pay of the incumbent so fixed is provisional and subject to re-paid of excess of drawl if any, due to fixation of pay as per existing rules and regulations, if detected subsequently, as per the direction of the appropriate authority.

6. All concerned are being informed accordingly.
