NOTIFICATION

The Governor has been pleased to allow Dr. Prahlad Ghosh, now posted as MO, Dist. Hospital, Chinsurah, Hooghly, who has completed 8 (eight) years' of continuous and satisfactory service from the date of his regular appointment in the said service without any promotion and enjoying the Scale under Pay Band 4A i.e. Rs./-15,600-42,000/-+Grade Pay of Rs.5,400/-(Scale No.16), to move to the next higher Scale under Pay Band-4A, i.e. Rs. 15,600-42,000/-+Grade Pay of Rs.6,600/-under W.B.S.(ROPA) Rules,2009 and its corresponding revised Pay "Level-17" under W.B.S.(ROPA) Rules, 2019 with effect from **29.10.2016**.

On his entitlement to the higher scale of pay of Rs. 15,600-42,000/-+Grade Pay of Rs.6,600/-under W.B.S.(ROPA) Rules,2009 and its corresponding revised Pay "Level- 17" under W.B.S.(ROPA) Rules, 2019, the pay of the Medical Officer shall be fixed in terms of Finance Department's Memo. No.3015 – F, dt.13.03.2001. Besides, the said Medical Officer would also be entitled for the pay and allowances as admissible to him in terms of rules & orders in force of the State Government from time to time.

While giving the effect to the above benefits to the concerned Medical Officer the date of his joining the West Bengal Health Services on regular basis, AND NOT ON ADHOC BASIS, as also continuity of his service should strictly be verified by the head of the institution vis-à-vis the entries in his Service Book. Discrepancies, if any subsequently been found, shall immediately be brought to the notice of this Department for taking further necessary action prior to giving effect to this order in respect of the said concerned Medical Officer.
