ORDER

To combat surge of Covid-19 cases, it requires immediate provision of new covid beds, augmentation of general and C.C.U/H.D.U beds at existing covid hospitals, setting up of M.G.P.S, laboratories, diagnostic facilities etc. Accordingly, Covid CCU/HDUs have been set up at different hospitals.

2. In view of the above, the undersigned is directed to accord administrative approval and financial sanction of Rs. 1,03,00,000.00 (Rupees One Crore & Three Lakh) only in favour of Director, I.P.G.M.E.R-Kolkata for "Procurement of CAT Items for the for the ICU and PICU beds for management of Covid affected patients at the Institute of Otorhinolaryngology and Head & Neck Surgery, IPGMER & SSKM, Kolkata".

3. The sanctioned fund of Rs. 1,03,00,000.00 is hereby released and placed as Advance in favour of the Director, I.P.G.M.E.R - Kolkata.

4. Financial Advisor, West Bengal State Health & Family Welfare Samity will act as the Drawing & Disbursing Officer in this regard.




8. This has approval of the Mission Director, National Health Mission & Secretary, Health & Family Welfare Department, Government of West Bengal.
