**ORDER**

To combat Covid-19 cases, it requires immediate provision of new Covid beds, augmentation of general and CCU/HDU beds at existing Covid hospitals, setting up of MGPS, laboratory, diagnostic facilities etc. All DMs and Principal of MCHs were empowered to take up necessary civil/electrical and constructional works in terms of order No. 133-HS(MS)/2(6)/HFW-43011(11)/85/2021 dated 28-5-2021. CMOH, Jalpaiguri has placed fund release proposal of PWD for some work at Jalpaiguri District Hospital.

2. In view of above, the undersigned is directed to accord Administrative Approval of Rs 40,65,926 and Financial Sanction of Rs. 68,54,291 (Rupees sixty eight lakh fifty four thousand two hundred ninety one) only in favour of **Chief Medical Officer of Health, Jalpaiguri** for payment to concerned PWD division in connection with execution below mentioned works:

7. Strict observance of all financial norms in respect of incurring expenditure out of the said fund must be followed and **data entry in NHM-PMS portal must be ensured by the concerned facility**.

8. This is issued with the approval of Mission Director, NHM & Secretary, Health & Family Welfare Department.


