ORDER


The five new Government Medical Colleges, namely Cooch Behar Government Medical College, Raiganj Government Medical College, Purulia Government Medical College, Rampurhat Government Medical College and Diamond Harbour Government Medical College are being established under the Centrally Sponsored Scheme under name and style "Establishment of new medical colleges attached with existing district / referral hospitals" having more than 200 bed strength. Consequently, it was decided that the following District Hospitals and Multi/Super-speciality hospitals will be the part of the aforementioned medical colleges as under:-

2. Accordingly, in order to avoid dual Administrative ambiguity in the context of setting up of the aforementioned medical colleges, the undersigned is directed by order of the Governor to say that, the following hospitals will be collectively treated as "Medical College & Hospital" as under:-

3. Principals of respective Medical Colleges are hereby declared as Head of Office of the entire establishment of such "Medical College & Hospitals" under Rule 5 (16A) of WBSR, Part-1, for all academic and administrative purposes.
4. The Medical Superintendent cum Vice Principal will act as overall administrative in-charge of the Hospital as Medical Superintendent and also work as Vice Principal in medical college.
5. The posts of Superintendent of the attached District Hospitals and Multi / Super-speciality Hospitals, detailed above will be re-designated as Deputy Superintendent;
6. Until the entire establishment of the aforementioned District Hospitals and Multi / Super-speciality Hospitals is subsumed under the respective "Medical College & Hospital", as an interim measure, the respective DDOs of the aforementioned hospitals will continue as DDO, in respect of officers and staff under their respective aegis, will retain financial powers, exercise delegated financial powers such that regular purchasing/ indenting/ sanctioning as permitted under WBDFPR and will work under MSVP.
7. The Officers of West Bengal Health Service will work under the Principal of respective medical college & hospital and the service will be utilised in respective Disciplines;
8. All concerned are being hereby informed.


