MD, West Bengal Medical Services Corporation Limited (WBMSCL) was requested to arrange procurement and supply of additional quantity of 575 Kg of biolarvicide (485 Kg of Bti 164 strain + 90 Kg of Bti ABIL strain) to the Chief Medical Officer of Health, Howrah and 450 Kg biolarvicide (380 Kg of Bti 164 strain + 70 Kg of Bti ABIL strain) to the Chief Medical Officer of Health, Basirhat HD vide this Department's order No. 645-HFW-18049/20/2019-PHP dtd 22.11.2019.

GM, WBMSCL, vide his letter No. HFW-41015/3/2019-WBMSCL/2725 dtd 26.11.19, has informed that Award of Contract had been issued to selected agency for this purpose and also requested this Branch for release of Rs 12,92,633 in favour of WBMSCL for procurement and supply of the same.

In view of above, the undersigned is directed to say that the Governor has been pleased to accord Administrative Approval and Financial Sanction of Rs 12,92,633 (Rupees twelve lakh ninety two thousand six hundred thirty three) is hereby sanctioned in favour West Bengal Medical Services Corporation Limited (WBMSCL) for procurement and supply of 575 Kg of biolarvicide (485 Kg of Bti 164 strain + 90 Kg of Bti ABIL strain) to the Chief Medical Officer of Health, Howrah and 450 Kg biolarvicide (380 Kg of Bti 164 strain + 70 Kg of Bti ABIL strain) to the Chief Medical Officer of Health, Basirhat HD.

Chief Medical Officer of Health, Howrah is requested to deliver 575 Kg larvicide to the Commissioner, Howrah Municipal Corporation for taking necessary actions.

The fund will be released from the head of Account 24-HF- 2210-06-800-002-31-02 in the current Financial Year 2019-20.

The fund sanctioned hereinabove is released and placed at the disposal of the Assistant Secretary and Drawing and Disbursing Officer, Department of H&FW Government of West Bengal who will act as the Drawing and Disbursing Officer for this purpose. The Drawing and Disbursing Officer shall disburse the funds in favour of the West Bengal Medical Services Corporation Limited by transfer credit to the deposit Account of the WBMSCL with Kolkata Pay & Accounts Office-III.

This order is issued in exercise of power delegated under Finance Department Group N Budget Branch vide their U.O. No. 1765 dtd 1.10.19 and read with the concurrence of this Department's Financial Advisor Branch's UO No. 232 dtd 3-12-2019.
