ORDER

It has been decided that House to House Survey works in connection with prevention and control of Dengue, would be done on fortnightly basis in urban areas during the period June'19 to Nov'19 (total 13 rounds).

In connection with above, fund was sanctioned and released in favour of State Urban Development Agency(SUDA) for payment of Honorarium to Volunteers, HHW, Supervisors for 12 rounds vide this Department's Order No.01-HFW-18049/5/2019-PHP dtd 10.4.19, No. 340(sanction)-18049/5/2019-PHP dtd 4.7.19, No 945(Sanction)-HFW-18049/5/2019-PHP dtd 16-9-2019 and No 1241(Sanction)-HFW-18049/5/2019-PHP dtd 25-10-2019. Also, Rs 79,70,400 was released to SUDA for payment of honorarium to Data Entry Assistants for 24 rounds out of 30 rounds vide order No 01(Sanction)-HFW-18049/5/2019-PHP dtd 10-4-2019.

Now, the undersigned is directed by the order of the Governor to say that the Governor has been pleased to accord Administrative Approval and Financial Sanction of Rs 2,74,25,100 (Rupees two crore seventy four lakh twenty five thousand one hundred) in favour of State Urban Development Agency(SUDA) for payment of the following items:

Director, State Urban Development Agency (SUDA) will act as DDO in respect of the fund being placed and he is requested to make necessary arrangements for subsequent release of the fund to the concerned ULBs as per existing calculation of fund.
