ORDER

- Each Sub Centre will have to be built at the sites as communicated to this Department at an unit cost not exceeding **Rs.12,80,700.00 (Rupees Twelve lakh eighty thousand & seven hundred only)** as per model plan & revised estimate with revised PWD SoR and introduction of GST from **1st July, 2017**.

- On receiving requisition, fund will be released in favour of District Health & Family Welfare Samity, Coochbehar District for subsequent placement of the same to the implementing agency and will book this expenditure in the FMR.
- No price escalation will be allowed further to implement the work. No other works other than the scheme sanctioned are to be implemented / take up against the approval accorded.
- The charge is debitable from the fund of NHM Flexi-Pool 2017-18 under the head of account '**Construction of Non-GPHQ Sub Centres**' [Tally A/c head - B.5.3.2]
- Statement of Expenditure & Utilization Certificate of the respective fund should be submitted to this Department in due course.
- Senior Accounts Officer, National Health Mission will act as the Drawing & Disbursing Officer for the said purpose.
