**MEMORANDUM**

The undersigned is directed by the order of the Governor to say that the Governor has been pleased to permit 1 (one) officer of the West Bengal Public Health-cum-Administrative Service, as shown in the following table, to undertake **postgraduate diploma course** at the place as mentioned in column [G], for the session 2020 and for that purpose the Governor has been pleased to place him on the **Trainee Reserve for the period of two years**, with effect from the date of his release from present place of posting or till the completion of the University examination of the course for the first time whichever is earlier.

2. He shall be released under local arrangement from his present place of posting by the concerned controlling authority in order to enable him join his course, after handing over the official charges.
3. Meanwhile, if on scrutiny and vigilance verification, the candidate is found to have been suppressing facts or furnishing false information, or in case of any adverse report, his candidature will liable to be cancelled and appropriate administrative action will be initiated against.
4. During the period of his placement on Trainee Reserve, the Officer will draw Pay & Allowances as admissible to him under the West Bengal Health Services (Cadre, Pay & Allowances) Rules and in terms of the existing Rules of this State Government.
5. The Officer, as placed on Trainee Reserve are subject to the condition that he shall, prior to his drawing Pay as Medical Officer on Trainee Reserve; execute bond in triplicate in the prescribed form undertaking to serve the State Government for a period of at least three years (for two year course) after completion of the course. The duly filled up bond should be submitted to the MERT Branch of Swasthya Bhawan for acceptance.
6. The Assistant Director of Health Services (Accounts) will act as the DDO in this regard while the Deputy Director of Health Services (Administration) shall act as Controlling Officer in respect of such officer.

7. The Pay & Accounts Officer-III, Kolkata, Pay & Accounts Office-III, Accountant General, West Bengal and other concerned are being informed.
8. He shall obtain release order from the concerned Institution immediately after completion of the course and report to the Director of Health Services, West Bengal for duties.
