No. 178 /HF/CFS/2A-1/2011 dated, Kolkata the 22<sup>nd</sup> June, 2021- In accordance with Section 31(2) of the Food Safety and Standards Act, 2006 every Petty Food Business Operator shall register themselves with such authority and in such manner as may be specified by regulations, without prejudice to the availability of safe and wholesome food for human consumption or affecting the interest of the consumers.

In view of above and in cancellation of this Department's Notification No.312/ HF/ CFS/ 2A-1/ 2011 dated 15.12.2020 the following Food Safety Officers posted at Kolkata Municipal Corporation are hereby directed to act as Registering Authority of Kolkata Municipal Corporation area for Petty Food Business Operators as required under regulation 1.2.1(5) of Food Safety and Standards (Licensing and Registration of Food Businesses), Regulations, 2011, until further notification.


