Subject: Granting of CAS benefit after completion of 08(eight) years of continuous and satisfactory service in respect of Smt. Aparna Ray, Sr. Lecturer, Medical College and Hospital, Kolkata.

MEMORANDUM

The undersigned is directed to say that Smt. Aparna Ray attached to Medical College and Hospital, Kolkata appointed to the post of Sr. Lecturer under West Bengal General Service (Nursing) and joined the said post on 13/12/2010 in the pay scale of Pay Band PB-4A (Rs-15,600/- - 42,000/-) with grade pay of Rs. 5,400/- under W.B.S. (ROPA) Rules, 2009.

2. Now 08(eight) years benefit under C.A. Schemes has been due to her on 13.12.2018 for completion of continuous and satisfactory service of 08(eight) years in the same post without any promotion on 12.12.2018. Smt. Ray is therefore eligible for career advancement to the next higher scale of pay in the Pay Band-4A (Rs-15,600/- - 42,000/-) with Grade Pay Rs. 6,600/- under W.B.S. (ROPA) Rules, 2009, corresponding to Level-17 (Rs. 67,300- 1,73,200/-) under WBS (ROPA) Rules, 2019 w.e.f. 13.12.2018, in terms of Finance Department's Memo No. 3015-F, dated 13.03.2001 read with Finance department's Memo No. 961-F (P2) dated 07.02.2011 and No. 6042-F(P2) dated 07.11.2019.

3. In the circumstances stated above, the Governor has now been pleased to allow 8 (eight) years CAS benefit to Smt. Aparna Ray, Sr. Lecturer, attached to Medical College and Hospital, Kolkata w.e.f. 13.12.2018 in terms of F.D.'s Memo No. 3015-F, dated 13.03.2001 read with Finance Department's Memo No. 6042-F(P2) dated 07.11.2019, in the following manner:

- a) She is entitled to draw her pay in the scale of Pay Band-4A (Rs. 15,600/- 42,000/-) with Grade Pay of Rs. 6,600/- under W.B.S. (ROPA) Rules, 2009 w.e.f. 13.12.2018 to 31.12.2019.
- b) She is entitled to draw her pay in the pay level-17 (Rs. 67,300-1,73,200/-) of the Pay Matrix under W.B.S. (ROPA) Rules, 2019 notionally w.e.f. 13.12.2018 to 31.12.2019 and actually w.e.f. 01.01.2020

4. The pay of the incumbent so fixed is provisional and subject to refund of excess drawl if any, due to the fixation of her pay as per existing rules and regulations, if detected subsequently a s per the direction of the appropriate authority.
5. She will earn next increment on 01.07.2020.
6. This order is issued with the approval of the Secretary (Nursing) of this Department.
7. All other concerned are being informed accordingly.
8. The previous order vide No.75-HFW-37099/1/2020-DIR-Nursing Sec dated 01.12.2020 is to be treated as cancelled.
