In partial modification of the AAFS HFW-18099/22/2022-PHP SEC-Dept. of H&FW/1893 dtd 8.6.22, the undersigned is directed to accord Administrative Approval and Financial Sanction of **Rs. 7,00,000 (Rupees seven lakh) only** in favour of **Director, IPGMER** for procurement of 1 Polysomnogram and 12 number Suction Machines through GeM.
