Administrative Approval of **Rs.22,56,18,000/-** (Rupees twenty two crore fifty six lakh and eighteen thousand) only for construction of 150 Bedded Indoor Building at Plot No. 25430 under Mouza-Andaranfulbari, JL No. 71, Toofanganj Mental Hospital, Cooch-Behar had been accorded vide this Department (M.S. Branch) Memo No. HF/O/PHP/6M-14/336/2014, dated 02/12/2014.
