MEMORANDUM

College of Nursing attached to Calcutta National Medical College & Hospital, Kolkata is functioning since long to run Post Basic B.Sc (Nursing) course with annual intake of 50 (fifty) students. But, till date, no post of non-teaching staff has been sanctioned for this college. The Health & Family Welfare Department, Government of West Bengal, has felt the urgent necessity to create some non-teaching staff for smooth functioning of that college. Accordingly, it was proposed to create and fill up the following posts of non-teaching staff.

5. Two (02) posts of part-time Karmabandhu are to be engaged on contractual basis at the remuneration of Rs. 3,000/- per month.
