

MEMORANDUM

In accordance to Notification No. HF/O/MA/326/4P-01/17/Pt-II/HFW-25099/19/2019-MA Dated 28-02-2019 of this Department and in pursuance to Cabinet Decision vide U.O No. 1093 Dated 27-08-2018 regarding amendment in fixation of permissible limit of Post Graduate Trainee Reserve in every academic year, the strength of total Trainee Reserve for the in-service Dental Surgeons of WBDS & WBDES cadre would be 10% (ten percent) of men in position who have completed a minimum 03 (three) years of service as on 31st March of the current year.

Fresh Trainee Reserve for each year is determined by deducting the number of Dental Surgeons who are continuing their respective courses as Trainee Reserve, from the total number of Trainee Reserve permissible. As the existing permanent strength of in-service Dental Surgeons of WBDS cadre and Faculties of WBDES cadre taken together is 578 as on 31-03-2021, the permissible T.R. strength calculated for the session 2021-2022 is 58, out of which a total number of 29 (twenty nine) Dental Surgeons/ Faculties are already continuing on T.R.

Therefore, maximum 29 (58-29) NEET qualified in-service Dental Surgeons may be allowed in the academic year 2021-2022, if selected.
