Administrative Approval was accorded vide Memo.nos. under reference for **“Conversion of 4041 (four thousand forty one) SHCs into SSK / HWCs under XV FC- Health Grants for FY 2021-22”** at a total estimated cost of **Rs. 151,53,75,000/-** (One Hundred Fifty One Crore Fifty Three Lakh Seventy Five Thousand only), against unit cost of Rs. 3,75,000 (Three Lakh Seventy Five Thousand) only per SHC-SSK.

Details of SHCs covered for conversion into SSK / HWC and scope of works (1) vide Annexure A & Annexure B respectively were sent along with order no. HFW-27011/317/2021-NHM SEC-Dept. of H&FW/0034, Dated 03/01/2022, (2) vide Annexure I of order no. HFW-27099/165/2021-ADLS (HFW)-Dept. of H&FW/1320, Dated 12/04/2022 and (3) vide Annexure II of order no. HFW-27099/165/2021-ADLS (HFW)-Dept. of H&FW/1373, Dated 21/04/2022


Now, in partial modification of the memo. nos. under reference, proposal for 03 (three) alternate SHCs of Murshidabad District sent by CMOH Murshidabad, in lieu of approved ones for being co-located or other valid reason, have been approved as additional one-time fund for operational SSKs, have been felt essential.
