II. They will draw pay in the scale of pay of Rs.5400-25200/- with Grade Pay of Rs.2600/- in Pay Band-2 under W.B.S (ROPA) Rules, 2009 plus other usual allowances as admissible under rules and orders of Govt. issued from time to time.

III. They will get the benefit of past services rendered by them towards Pension/Gratuity/Leave etc.


IV. This order of promotion is being done on the basis of latest records available from the concerned office(s) and subject to verification of marksheet/admit card/certificate from the appropriate authority and will be cancelled if found wrong at any stage.

V. This order is to take effect from 01.03.2018.

VI. They should join the post immediately, failing which this order stands cancelled to that respect.
