ORDER


In terms of Notification No. 251-Emp., Dated 03.12.2013 of the Labour Department, Government of West Bengal, the following 01 (one) candidate had been appointed to the post of **General Duty Attendant** as mentioned against her name in Column III as per existing rules, (in the exempted category) **on compassionate ground** in terms of relevant orders issued by the Department of H & FW and accordingly the candidate is placed under the disposal of the concerned authorities of the hospital/institution under the Directorate of Health Services, Government of West Bengal, as mentioned against her name in Column IV.
