Kar Medical College & Hospital, 1 Khudiram Bose Sarani, Kolkata -700004 is hereby directed to **show cause** as to why the above mentioned period of absence shall not be considered as unauthorized one and disciplinary action should not be taken against her accordingly, within 7(Seven) days from the date of receipt of this memorandum positively.
