

2. Commuted Leave for 28 (Twenty-eight) days from 09.11.2020 to 06.12.2020 in lieu of 56 Half Pay Leave.
3. Commuted Leave for 09 (Nine) days from 07.12.2020 to 15.12.2020 in lieu of 18 Half Pay Leave in terms of Rule 173 of W.B.S.R Pt.I.
4. Earned Leave for 19 (Nineteen) days from 16.12.2020 to 03.01.2021 in terms of Rule 169 of WBSR Part-I.
