ORDER

To combat probable 3rd surge of Covid-19 cases, it requires immediate provision of new Covid beds, augmentation of general and CCU/HDU beds at existing Covid hospitals, setting up of MGPS, laboratory, diagnostic facilities etc. Thus, PWD and other concerned agencies have been requested to take up requisite civil and electrical works at the concerned health facilities. 
